- Complete Structural plans (Must be on a minimum of 11" x 17" paper)
- **Design development drawings** (Drawings indicating size of the building, Use, Group, and Type of Construction.)
- Complete site, Drainage, Grading plan (Drawn to scale, showing the actual dimensions and shape of the lot to be built upon; the exact sizes and locations of existing buildings and structures, if any, on the lot; and the location and dimensions of the proposed building or alteration, drive way location and tie in to street, sidewalks, setbacks, drainage, hydrant locations etc.)
- Complete Structural plans including:

Cover sheet (Cover sheet typically includes a front view of the plan, index of pages included, and other miscellaneous notes and details.)

Foundation plan (Foundation plans describe to the builder, the type of foundation requested by the home owner or the type of foundation required by a certain geographic area. In most cases, the foundation plan will include footing sizes and locations, footing details and other important information needed to properly construct the home.)

Dimensional floor plan (The floor plans locate all walls, interior and exterior, of the entire building, denote ceiling heights and treatments, locate all plumbing fixtures, cabinets, door and window locations and sizes, gives square footage measurements, locate water heaters and HVAC systems.)

Roof plan (The roof plan depicts the roof type, plate heights and roof slope of each plane.)

Electrical layout (The electrical plan depicts the general location of all interior and exterior electrical devices. This generally includes light switches, electrical outlets, ceiling fixtures, and smoke detectors. The electrical plan will also generally locate the breaker box and power entry.)

• Complete Storm Water SWPPP plans and specifications (if disturbing more than 1 acre)

All HVAC/R should follow the 2021 International Mechanical Code

A review by the following departments will be required on new projects.

- Pine Bluff Inspection & Zoning Department
- Pine Bluff Wastewater Utility
- Pine Bluff Street Department

1. Inspections and Certificate of Occupancy

- All construction work requiring a permit shall be inspected per the 2021 Arkansas Fire Prevention Code Volume III (IRC 2021).
- As per Code Section 110 of the 2021 Arkansas Fire Prevention Code Volume III, a
 Certificate of Occupancy is required prior to occupying a new building or any building (or
 part thereof) that has undergone a change of occupancy classification, use, or nature.
 Each individual tenant in multi-tenant buildings shall have a Certificate of Occupancy
 that will be issued following an approved final building inspection.
- 2. The time required to process a plan review on new projects and additions is five (5) working days. A letter of requirements will be faxed or mailed to the applicant or other designated person upon completion of the plan review. Provide complete name, address, phone number and fax number of all interested parties.

- **3.** The applicant is expected to obtain the permit and pay all fees within thirty (30) days after notification that the permit is ready for issuance.
- **4.** State law requires that contractors be licensed in the State of Arkansas before bidding or performing work in excess of \$50,000.00. For more information please contact:
